The EoECPH has been tasked by the Chief Pharmacists in the East of England to provide regional homecare support services to improve the governance of homecare services, make best use of local trust resource, ensure compliance with the Standards<sup>1</sup> and minimise duplication of workload.

The EoECPH will centrally collect data relating to all homecare medicines services provided to member trusts by all homecare providers to support management of homecare medicines at local, regional and national levels.

#### The aims are for:

- Each **Trust** to have access to accurate performance and sales data for all homecare services to allow effective management at a local level with the need for ad hoc reporting.
- The Regional lead to analyse and compare consistent performance and sales data for the whole region to allow identification and sharing of best practice and effective market management
- The National lead to have access to consistent regional data where required for analysis.
- **Homecare Suppliers** to provide data to a single location in a single format for the region thereby reducing burden on reporting teams.

All homecare providers are expected to meet the report requirements as detailed below.
