## NHS Improvement Update

The [Purchase Price Index and Benchmark Tool \(PPIB\)](#) is now rolled out to around 100 acute Trusts with the remainder needing to complete training prior to obtaining two log-ins.

Some Trusts are yet to provide their July to September data, rebate information or contact details. This needs to be uploaded as soon as possible. Starting next month the Operational Productivity (Lord Carter) procurement team will start to ask regional NHS Improvement directors to chase Trust Boards directly for those Trusts not up to date.

NHS Improvement is exploring how to roll out the PPIB tool to remaining Trusts by April 2017. Meanwhile Trusts may join for an annual fee of £3,500 which includes two licences.

## NHS CPP Launches New National Clinical Staffing Framework



The Hub is pleased to announce that the new National Clinical Staffing framework agreement has been launched and will help give Trusts access to agencies that meet regulators' criteria for the "cost-effective supply" of temporary staff.

The framework was developed by the NHS Collaborative Procurement Partnership, which includes the four NHS procurement hubs working together (London Procurement Partnership, NHS Commercial Solutions and the North of England Commercial Procurement Collaborative as well as the East of England Hub) and has the approval of NHS Improvement. (Formerly Monitor.)

The contract provides access to a wide range of staff roles with charges in line with NHS Improvement's pay and charge rate caps. Pay caps for agency staff – along with ceilings on total Trust spending on agencies – were introduced last year by regulators in a bid to help control spiralling temporary staffing costs and were lowered again in February and April 2016. NHS Improvement has already credited these caps with delivering savings on agency spend of around 20% across the NHS.

The framework will run for two years and replaces the first national NHS framework for the supply of nursing and nursing-related staff, which was created in 2014 and expired in September 2016. More than 400 staffing agencies have been awarded a place on the framework and all suppliers have been audited to ensure ability to comply with NHS pre-employment check standards.

These should point to the development of shared services under STP plans where it is expected that Trusts will consolidate procurement (amongst other corporate and administrative services) at a minimum of STP level. ### Clinical Consumables Framework Tender

The Invitation to Tender has been issued for a new clinical consumables framework. The aim of the framework is to provide a single solution for a wide range of related products used in the theatre environment.

The ITT was issued on 5<sup>th</sup> September and the deadline for tenders was 14<sup>th</sup> October, with the award expected in late December 2016. The framework will include the following product areas:

### Theatre Surgery Consumables Framework Tender

The Invitation to Tender for the new Theatre Surgery Consumables was also issued in September 2016, with tenders due in by 8th November and the contract award expected in January 2017.



The framework will cover the following areas:

- Minimal Invasive, Surgical Stapling and Laparoscopic surgery (including energy devices)
- Wound Closure, Sutures and Tissue Glues
- Haemostats
- Surgical Mesh
- Gynaecology Implants and surgical consumables (TVT)
- Urology, including Stents, Implants and consumables
- Breast Implants

### Continence Framework Update

Three Trusts in the region have directly awarded under the Continence Framework and are now in the implementation phase.

The opportunity figure for all three combined stands at around £600k savings per annum. Each Trust stands to make 20% - 25% savings on their current costs.

Benchmarking is in the process of being conducted for other Trusts within the region and is expected to yield similar percentage savings opportunities.

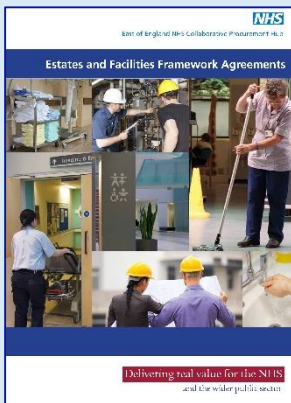

- Partial Managed Continence Home Delivery Service split between Trust and Contractor
- Fully Managed Total Continence Home Delivery Service

## DPS for Minor Building Works Case Study

A Dynamic Purchasing System (DPS) enables smaller enterprises to bid for public sector work and suppliers can apply to join the DPS throughout its life, unlike a standard framework.

The DPS for Minor Building Works was established as a compliant route to access suppliers of lower value building services and has proved to be a useful tool for a number of Trusts who are currently using it.

Benefits for Contracting Authorities:

- Shortened procurement times as advertisement in OJEU and PQQ stage have already been undertaken - no further advertisement is necessary.
- Increased competition as local providers can apply to get onto the DPS at any time during its period of validity.
- Participating organisations can develop their own specification, based on pre-developed templates, to meet their own requirements and formulate the award criteria more precisely.
- Award of individual tenders can be quicker than under some other procedures - the minimum time limit for return of tenders is 10 days.

In this particular case, the DPS agreement generally applies to minor building works projects valued up to £500,000, although some projects may exceed this value.

All suppliers who have been awarded on to the DPS had already passed the first stage, the pre-qualification questionnaire (PQQ).

### Scope

The bid categories covered under Minor Building Works DPS are listed overleaf.

Construction Work, Building Construction Work, Repair and Maintenance Services, Building Services Maintenance (M & E), Electrical Installation & Maintenance/Services, Building (General), Building Refurbishment Over



£15k, Building Repairs And Improvements (Max Notation £15k), Building (Design & Construct), Painting & Decorating

(General), Joinery, Doors, Windows (Pvcu), Glazing, Roofing, Brick And Blockwork, Tiling (Wall), Plumbing, Flooring (General), Demolition Work, Scaffolding, Asbestos Removal/Treatment, Site Clearance, Landscaping, Fencing, Building (Hospitals), Building (Multi Storey Car Parks) to include maintenance, Drainage, Fire Protection (Sprinklers), Fire Protection-Smoke Vents (Automatic), Insulation (Building), Locksmiths, Office Fit Out, Partitions, Plastering, Road Maintenance (Minor Works), Building (Prefabricated/Temporary) Supply & Install and Listed Building Work.

## Clinical Product Specialists Update

The Clinical Product Specialist (CPS) team has been working with new suppliers and has identified savings on a number of products.

There have been changes on the NHS Supply Chain contract for surgical stockings with a new distributor taking on a popular range. The team is working on a Trust by Trust basis to assist clinicians and procurement staff with the implementation.

A medical pulp supplier has approached the CPS team and offered regional pricing on their products for Trusts who are not in contract. The team has been carrying out a spend analysis and is working with Trusts where savings have been identified.

Safer sharps remains high on the agenda for the CPS team and savings have been identified by switching insulin pen needles.

The team has been working closely with the mental health and community Trusts across the NHS Commercial Alliance identifying savings and assisting with evaluations and implementations.

## Pharmacy Automation Systems

The Hub is at the market engagement stage at present and compiling the review gateway 1 and 2 to current stakeholders for agreement.

We have a baseline of what systems our Trusts already have in place and areas of interests. We will be sharing that with Trusts to validate. Potential areas of inclusion at this stage are:

- Drug cabinets - pharmacy, wards, theatres and A&E departments
- CD cabinets - wards and pharmacy departments
- Fridge locks
- Robotics - full pack and single dose dispensing
- Drug discharge carts
- Prescription Payment kiosks
- Warehouse management systems

## Prescribing Support Systems

We have started work on a new NHS Collaborative Procurement Partnership framework agreement for prescribing support systems.

The scope is currently being defined and we will be issuing a short survey out to Trusts to gather information on what systems are currently being used in their Trust setting.
